### 10. Old Business:

**Ordinance:** Private Fire Protection

Now Therefore, the Romney Town Council has the authority to adopt Rates, Rules and Regulations for Furnishing Water at Romney and vicinity, Hampshire County, West Virginia.

### **Private Fire Protection**

Permanent fire protection apparatus, including hydrants and sprinkler connections, owned and maintained by an entity other than the Town of The Romney may be connected to the Water Distribution System where comparable. Those connections are be used only for fire protection and in extinguishing fires, except as otherwise expressly authorized by the Town's ordinances or by Romney Town Council. All private Fire Protection connections are to be made only by prior express written notification to the Town of Romney Business Office. Private fire connections shall be assessed and pay an annual fee based on the size of the connection to the Water Distribution System, as follow:

4-inch service line with hydrants, sprinklers,	
and/or hose connections	\$180.00
6-inch service line with hydrants, sprinklers,	
and/or hose connections	\$200.00
8-inch service line with hydrants, sprinklers,	
and /or hose connections	\$220.00
10-inch service line with hydrants, sprinklers,	
and/or hose connections	\$240.00
12-inch service line with hydrants, sprinklers,	
and/or hose connection	\$260.00

This ordinance shall become effective on the date of passage and adoption. The first reading of this ordinance having been moved by Councilman Hott and duly seconded by Councilman McKenery. Motion carried. Seconded Reading in Title Only motion by Councilman McKenery. Seconded by Councilman Laitenberger. Motion carried.

#### 11. New Business:

**Resolution**: Whereas, the Romney Town Council finds that costs are incurred by the Town in providing copies of municipal records.

Now Therefore the Romney Town Council does Hereby Resolve as Follows:

The fee(s) for copies is one dollar (\$1.00) per page.

The fee(s) set forth are hereby established and set and become effective upon adoption;

The fee (s) established and set shall not apply to any government entity.

Furthermore, the Governing Body does hereby authorize Mayor Beverly C. Motion by Councilman McKenery. Seconded by Councilman Laitenberger. Motion carried.

### 12. Mayor's Report:

- A. The "Two Hour Free Parking" Pilot Program continues to receive positive response. The Pilot period will run through February 28, 2019. Two additional signs have been added on South High Street to prevent misunderstanding.
- B. The next Romney on the Menu will be Friday, November 16 at 5:30 at BOR Community Building. Dan Oates will continue his presentation on the 1940 census. October's program was rescheduled to November because of a date conflict.
- C. The Town continues to encourage property owners and residents to clean up unsightly property and to rid the Town of unregistered vehicles. Property owners should be aware that when grass is cut it is to be cut so that the clippings land on the property owner and not in the street. Certified letters are sent allowing 10 days for improvement, non-compliance resulting in summons to appear before the Municipal Judge.
- D. The latest communication on the Streetscape Project for the north side of Main Street from Endler Avenue to High Street is that plans moved to Contract Administration on July 7. The report from September 17 is that the project has been accepted by Contract Administration and is in the line for advertising. DOH projects November 13, 2018 as the letting date.
- **E.** FEMA update, we are nearing completion of submitting disaster-related damage information.
- F. The Rannell's Acres Sewer Project is nearing the time for construction bids. Another Status Conference Call is scheduled for November 14 at 10:00 a.m.
- G. Councilwoman O'Brien and the Mayor worked on submitting an AHEC grant for the Romney Rail Line Heritage Trail. The requested amount for paving and planting is \$14,313.00. Grants will be announced the first of January, 2019.

- H. Other grants for a fourth police vehicle and public works pickup truck were submitted to USDA under the Community Facilities Loan and Grant Program.
- I. Police Officer Chris Carroll submitted a grant to State Farm in the amount of \$13,300.00 for 4 (four) new radar units.
- J. The final plans for the Veteran's Day Luncheon on November 11, 2018, are being made. It will be at the Bottling Works to begin at approximately 1:30 p.m. This event is free and open to the public. Please encourage all veterans to attend.
- K. Interviews for the Capital Improvement Projects for both Water and Sewer distribution have been held. Thrasher Engineering was chosen to proceed with the project. Region 8 will help with securing funding.
- L. Tom Elliott of USDA in Elkins was here last week to examine the rat situation in the Washington Street area of Romney. They will send info on poison boxes to put into drains under storm grates during dry events to treat for rats.

- 1. Microtech Designs completed the Source Monitoring project by tying in the SCADA systems to the monitoring panel. If an emergency occurs regarding contaminants in our source water, an alarm will be sent to members of the Water Department.
- Donald Oates passed his Class 1 Operator's test and has completed about half the hours required to become a Class 1 Operator.
- **3.** Will be sending out an invite for the next Personnel meeting in the next two weeks to begin assigning pay ranges to all positions.
- **4.** Animal Care & Control Board held their first meeting on October 11, 2018. The first order of business is to review an update the ordinances pertaining to animals in corporate limits, as well as review the agreement with the county for handling stray cats and dogs.
- **5.** Working on offering Direct Deposit to employees as of January 1, 2019.
